It is available on a dedicated e-learning platform (my-VITA) and consists of around 24 hours of material and has the added value of functioning as a personal portfolio to collect evidence of skills and competences. The platform supports professional networking as it provides an open learning environment with a forum for sharing materials and promising practices – facilitating an effective community of practitioners within prison education in the EU. Prisons can be environments where teachers and professional educators work in relative isolation, this opportunity to share experiences and practices is particularly invaluable.
